#### 0903 West End Police Report - Lt. Sean Migues.

If you see the street is full of people and the noise is increasing, feel free to call the nonemergency police number earlier rather than later. There are 4 officers on duty from 61<sup>st</sup> Street to the San Luis Pass. Most of the efforts are concentrated around Heards Lane and Wal-mart. Additional calls for assistance help shift the amount of officers to our area.

#### 0915 US Army Corps of Engineers Overview – Lt. Col. Ian O'Sullivan, Deputy Commander

The Galveston District focuses on civil works and civil projects. The majority of the projects revolve around flood protection through dams and storm surge protection.

The Coastal Texas Project (Ike Dike) spans from south Padre Island through the Bolivar Peninsula. The Bolivar Roads gate system is planned to be 2-miles long. The current design includes 4 large swing gates that protect the two 650-foot wide channels, 2 small sector gates

for smaller craft, 15 intermediate lift gates (~3,900'), and 1,500' of flow through environmental gates.

These gates are planned to be constructed in conjunction with a dune system to help move water detoured by closed gates during a storm. The dune system will include extending the shoreline and ensuring there is a double dune system between the shoreline and housing areas.

Outside of Galveston Island, there will be other ecosystem restoration projects to protect the entirety of the Texas coastline. These projects include building breakwaters, replenishing marshes, rebuilding beaches, and bolstering oyster reefs.

The current project status is that we are through the initial study and are beginning the design phase. The project has received congressional authorization through the Water Resources Development Act (WRDA). The gates system design process is expected to be 7-9 years. The double dune system and ecosystem restoration design is expected to take significantly less time. The presentation by Lt. Col. Ian O'Sullivan, Deputy Commander, is as follows.

Tax rates are being lowered, but the property taxes are going to increase. That being said, there is currently a "no net increase" in your total taxes.

The \$51 million bond for the additional construction efforts at the Port of Galveston was approved. This will be paid for by Carnival Cruise Lines, mainly for Pier 25 efforts.

The street study is ongoing. These studies measure the severity of roads and drainage issues to determine the order of maintenance efforts.

A Short Term Rental (STR) task force is being implemented. This task force will review occupancy rates, parking plans, and governing ordinances to better benefit our residents.

## 1040 Gulf Coast Protection District (GCPD), Sally Balko

The Texas General Land Office (GLO) and GCPD are the non-federal sponsor for the Coastal Texas Storm Surge Project (Ike Dike) for ecological and funding/planning portions of this project, respectively.

The Gulf Coast Protection Trust Fund will allow the GCPD to funnel allocated non-federal funds to the Coastal Spine Project. These funds are required to match half of the federal funds for the current and future projects. These state dollars have been acquired.

Bi-partisan infrastructure funding is on-going. Receiving federal money issued as part of the annual appropriations process is projected for 2025 at the earliest.
